It also includes an assessment of the judgements made by the Director of Accounting Services in the preparation of the financial statements, and of whether the accounting policies are appropriate to the circumstances of the Loan Fund, consistently applied and adequately disclosed.

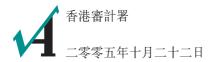

帳項註釋

1. 目的及立法

貸款基金為財務委員會核准的計劃提供款項,包括為本港的發展計劃提供貸款及墊款,以及為學生提供貸款。本基金是按照立法局於一九九〇年三月十四日根據《公共財政條例》(第2章)第29(1)條所通過的一項決議(以下簡稱為「決議」),在一九九〇年四月一日設立。

2. 會計政策

- (i) 除下文第 (ii) 項另有規定外,貸款基金的帳目是 以現金記帳。收支項目只在收到或支付款項時才 記錄下來,不論屬經常或非經常性質。
- (ii) 本基金的資產負債表列出基金的整體財政狀況, 並包括未償還貸款總額。
- (iii) 就本帳目而言,或有負債是指:
 - (a) 由已發生的事故而導致可能產生的責任,而 這些責任會否產生則須視乎日後會否發生一 宗或多宗不能全受政府控制的未確定事件而 定;或

NOTES ON THE ACCOUNTS

1. Purpose and Legislation

The Loan Fund finances loans and advances for schemes of developments in Hong Kong and loans to students under schemes approved by the Finance Committee. It was established with effect from 1 April 1990 by a Resolution (hereinafter referred to as the Resolution) passed by the Legislative Council under section 29(1) of the Public Finance Ordinance (Cap. 2) on 14 March 1990.

2. Accounting Policies

- (i) Subject to (ii) below, the accounts of the Loan Fund are kept on a cash basis. Transactions are recorded when moneys are received or paid, whether they relate to recurrent or capital transactions.
- (ii) The Statement of Assets and Liabilities is structured to show the overall financial position of the Fund including the total outstanding loans.
- (iii) For the purposes of these accounts, a contingent liability is defined as:
 - (a) a possible obligation that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Government; or

 - the amount of the obligation cannot be measured with sufficient reliability.




