- (a) 在 2003/04 年度,香港房屋協會(房協)就夾心階層住屋貸款計劃及首次置業貸款計劃分別還款 0.52947 億元及 8.29792 億元。二〇〇三年十二月,政府將這些計劃的貸款餘額以面值售予香港按揭證券有限公司(按揭公司)。按揭公司保留部份款項作遞延代價,用以承擔房協的行政費,借款人拖欠的還款,以及按揭公司應收利息的差額。是項出售安排的淨收入經已收訖,並計入2003/04 年度的帳目中,而有關的遞延代價將會在所有個別貸款償清後結算。
- (b) 指售出貸款的帳面值與完成上文第 (a) 項的出售安排後 所得的淨收入之間的差額。
- (c) 包括:(i)二〇〇三年五月以面值把部份未償還貸款售予 按揭公司的收入 47.79629 億元,以及(ii) 2003/04 年度個 別借款人償還的貸款。
- (d) 這些是週轉資金,因此所顯示的款項是截至二〇〇四年 三月三十一日的未償還貸款。

- (f) 這些包括給予公務員的房屋資助購屋貸款、給予大學、香港專業教育學院、菲臘牙科醫院、香港教育學院及香港演藝學院的學生的貸款、給予免入息審查貸款計劃的貸款、給予認可專上學院的學生的貸款、給予香港留英學生的貸款、給予因工作而受傷的僱員及死亡僱員遺屬的貸款、嘉道理農業貸款基金—海魚養殖戶的貸款、給予家禽批發商及零售商的貸款、魚類統營處貸款基金—給予漁民的貸款及給予中小型企業特別信貸計劃的貸款豁免償還,分別為132.7萬元、125.3萬元、22萬元、0.3萬元、1.2萬元、3.5萬元、6.4萬元、3.7萬元、5萬元及1,483.9萬元。

Notes:

- (a) In 2003-04, Hong Kong Housing Society (HKHS) repaid \$52.947 million and \$829.792 million under the Sandwich Class Housing Loan Scheme and the Home Starter Loan Scheme respectively. In December 2003, the Government sold the remaining balance of the loans to the Hong Kong Mortgage Corporation Limited (HKMC) at par with part of the consideration deferred to cover the HKHS's servicing fee, borrower's defaults and any shortfall in HKMC's interest receipts. The net proceeds from the sale have been received and brought into account in 2003-04, while the deferred consideration will be cleared after all the individual loans have been repaid.
- (b) This represents the difference between the book balance of the loans sold and the net proceeds received from the sale pursuant to the arrangement as described in (a) above.
- (c) This is made up of (i) proceeds of \$4,779.629 million from the sale of a part of the outstanding loans at par to HKMC in May 2003 and (ii) repayments from individual loan recipients in 2003-04.
- (d) These are revolving funds and therefore the amounts shown are outstanding loans as at 31 March 2004.
- (e) These include capitalized interest amounting to \$2.885 million in respect of the bridging loan to Employees Compensation Assistance Fund Board, \$0.964 million in respect of Kadoorie Agricultural Aid Loan Fund and \$18.385 million in respect of the Hong Kong Productivity Council loan, as at 31 March 2004.
- These include amounts written off as follows: \$1.327 million in respect of Housing assistance for civil servantshousing loans, \$1.253 million in respect of loans to students of the universities, the Hong Kong Institute of Vocational Education, Prince Philip Dental Hospital, Hong Kong Institute of Education and Hong Kong Academy for Performing Arts, \$0.22 million in respect of the non-means-tested loan scheme, \$0.003 million in respect of loans to students of approved post-secondary colleges, \$0.012 million in respect of loans to Hong Kong students in the United Kingdom, \$0.035 million in respect of loans to employees injured at work and dependants of deceased employees, \$0.064 million in respect of Kadoorie Agricultural Aid Loan Fund—loans to mariculturists, \$0.037 million in respect of loans to poultry wholesalers and retailers, \$0.05 million in respect of Fish Marketing Organization Loan Fund-loans to fishermen and \$14.839 million in respect of loans to special finance scheme for small and medium enterprises.
